STARTUPS CONTRIBUTE TO EUROPE'S ECONOMIC DEVELOPMENT

2. Startups rely on open access to the internet and an unobstructed digital market to grow. *We ask policymakers to commit to keeping the internet an open marketplace for everyone.*
3. Startups are global from day one and need a regulatory framework that enables them to conquer the world, starting in Europe. *We ask policymakers to commit to fostering a global mindset that enables startups to compete in the European single market and beyond.*

STARTUPS SUPPORT USERS, CITIZENS AND THEIR COMMUNITIES ACROSS EUROPE

1. Startups embrace diversity and inclusiveness as part of their business' success. *We ask policymakers to commit to encouraging entrepreneurship for all and to be a champion for accessible and inclusive technologies.*
2. Startups put users at the heart of their innovations. They can only succeed with the trust and satisfaction of their users. *We ask policymakers to commit to seeing new legislative proposals through the perspective of citizens and users as well as the products and services they benefit from.*
3. Startups are education labs. *We ask policymakers to commit to supporting startups to educate the next generation of entrepreneurs and innovators, we want to improve the development of digital skills at all levels and ages.*

STARTUPS KEEP EUROPE INNOVATIVE, COMPETITIVE AND FORWARD-LOOKING

1. Startups fail and that failure creates value. *We ask policymakers to commit to promoting an environment in Europe where entrepreneurs are encouraged to take risks.*
2. Startups drive new technologies such as Artificial Intelligence and Blockchain. *We ask policymakers to commit to making sure that Europe spearheads efforts in AI and Blockchain, facilitating investment in R&D to create innovation and value – while not over-regulating the sector, ensuring it can evolve.*
3. Startups aspire to be the next European tech champion. *We ask policymakers to commit to ensuring that Europe is open to startups and offers the right regulatory and entrepreneurial conditions to build the next big thing.*
