TELEMEDICINE IN EUROPE

CHALLENGE

The COVID-19 pandemic has caused a sharp increase in demand for online consultations. Venture capital funding for telemedicine has more than tripled in Q1 2020. However, outdated regulatory frameworks obstruct telemedicine accessibility and startups' potential to scale.

ACTIONS

- We interviewed telemedicine startup founders to identify the impact of COVID-19 on their business, and the barriers the telemedicine sector is facing.
- Published a report <u>Telemedicine in Europe</u>: <u>Opportunities and Challenges</u>, which lays down 6 recommendations for policy makers to support telemedicine's uptake.
- Produced a series of short videos,
 <u>Conversations with Telemedicine Startup</u>
 <u>Entrepreneurs</u>, to share their impressive stories and perspectives on policy.

FINDINGS

- The pandemic advanced the adoption of telemedicine services by at least 5 years.
 However, the private sector is adopting telemedicine at a much faster pace than the public sector.
- Founders' recommendations focus on establishing clear frameworks for delivering and reimbursing teleconsultations, standardisations of eHealth services, enabling e-Prescriptions and exchange of EHR across Europe.



COVID-19 & STARTUPS

CHALLENGE

The COVID-19 pandemic had unprecedented economic and social implications. In the first months of the health crisis, 20% of startups pivoted to tackle the pandemic, including digital health startups who helped save lives. It is vital to include them in the post-COVID recovery plans.

ACTIONS

- We engaged digital health startups to collect their feedback on the impact of COVID-19 and shared their contributions.
- Published <u>COVID-19 & digital health startups:</u>
 an <u>overview</u>, showcasing our members who
 quickly adopted their solutions to address the
 pandemic.
- The AFS COVID-19 Working Group published <u>Startups Recommendations for the post-</u> <u>COVID-19 recovery</u>, a handbook that provides recommendations in the fields of investment, talent and policy.

HIGHLIGHTS

- In response to <u>AFS requests</u>, the European Commission adopted an extension of the State Aid Temporary Framework to enable support for startups in the EU.
- The Next Generation EU recovery instrument and the EU4Health programme outlines digital transition as one of the key priorities. We encourage policy makers to tap into the potential of startups by investing and creating a hospitable policy environment.

BUILDING BRIDGES BETWEEN STARTUPS AND POLICYMAKERS

CHALLENGE

Digital health startups have the potential to be key contributors to the digitalisation of healthcare. However, they have limited resources to navigate complex regulation. It is essential to engage in dialogue and build partnerships with all stakeholders in healthcare to build consensus and reduce barriers.

ACTIONS

- We partnered with the <u>Patients' Digital</u>
 <u>Health Awards</u>, an initiative that fosters
 connections between startups and Patient
 Associations, and brings spotlight to digital
 health entrepreneurs. The first European
 edition attracted innovators from 13
 countries.
- We hosted a webinar "Digital health innovation & startups during COVID-19 and beyond" with MEP Brando Benifei, bringing together the award-winning innovators, policy makers and patient associations for a discussion about key challenges the digital health sector is facing.

FINDINGS

- Startups' needs include improving access to health data and developing a European framework for reimbursement of digital health solutions.
- For startups, patient engagement throughout the product development process is crucial to success. For us, building bridges with all actors in the ecosystem strengthens advocacy impact.

PERSPECTIVES FOR 2021

As the digitisation of healthcare is accelerating at an unprecedented speed, digital health policy has become a top priority in policy-making in the European Union and across the world. Digital health startups play an important role in transforming our health care systems, improving patient outcomes and enhancing clinical decision-making.

Improving health data access and exchange, regulating AI, increasing the uptake of digital tools, and cross-border interoperability of healthcare systems are key goals of digital health agendas and conversations that will shape the regulatory landscape for digital health innovation years to come.

Digital health funding broke a record this year with \$14.8 billion in global venture capital investment in 2020, and the market is expected to grow exponentially in the coming years. Member State policies also play a vital part in creating a favourable investment environment. For example, the new Digital Healthcare Act, adopted in Germany this year, enabled reimbursements for digital health apps by statutory insurances and prescriptions of digital products to patients. Developing a more coordinated EU approach would help scale such best practices across Europe.

At Allied for Startups, we will scale-up our advocacy, outreach and stakeholder engagement activities to bring the voice of digital health startups to policy-making. Our growing membership and the seat at the Commission's eHealth Stakeholder Group empowers us to set ambitious goals for 2021.
